- (1) The Terminal Handling Charge is additionally applicable for each restowage operation, i.e.: a) discharge of Container from Vessel/Rail Platform into Stacking Area and loading of Container back onto the Vessel; or b) the loading of a Container from Stacking Area onto the Vessel/Rail platform and discharge of the Container back to the Stacking Area.
- (2) Terminal Handling Charge is earned and therefore payable with first lifting operation.
- (3) Direct deliveries (load or discharge) from/to Vessel to/from railway wagon are subject to the same Terminal Handling Charge and only allowed following the prior written approval of the Service Provider.
- (1) Terminal Handling Charge for out-of-gauge Containers and Dangerous Cargo Containers is the standard Terminal Handling Charge plus 20%.
